- **V147. Update: Brief update** from Police, SLDC and CCC, Police:
 - During last 30 days in Ulverston: 25 reported crimes in total
 - Crimes of Note: 3 Assault with injury and 1 assault without injury.
 - 1 Attempted Burglary Steel St. 2 Shoplifting offence in town. No crime trends, either offence or location. Calls for the Police in Ulverston: 126
 - Furness Peninsula Blue Light Hub work now under way. There will still be
 a Police Desk maintained in the Coronation Hall. It is the intention that
 Sgt Johnston and his current team will be located there.
 - There has been a marked improvement in town centre parking which is due to increase patrols and enforcement by the council enforcement officer. Sgt Johnston will be making representation for this to continue.
 - Sgt Johnston and team ran an Off-Roading operation last week, which was filmed by the BBC for the Inside Out programme.

- Work with Street Scene officers to ensure cleaner streets.

CCC. Cllr Wilson:

- As plans for Integrated Care Communities emerge for Health Care services in our areas (Dalton & Ulverston), Cllr Wilson has attended joint meetings with NHS, from Morecambe Bay as well as the local doctor who heads up the ICC.
- County Councillors and officers present wished to use existing Health
 Preventative Measures to become embedded PLUS Heart and Stroke
 issues with residents in our area to be put at the top of treatment needs.
- Council may wish to invite leaders from the *Integrated Care Community* ICC to meet with us at some near point in the future.
- Many infrastructure improvements are taking place in the Ulverston area at present. Thanks to partnership working by CCC, Ulverston's road and associated works have benefited.
- Some buildings may become identified as potential assets for transfer to community groups.
